Clarlene Jacobsen: In to talk to the Board in regards to her son renting the Town Hall for a going-away party for a friend. The Board agreed to rent the hall for \$20.00 and a promise the party would be supervised and no alcoholic beverages would be on the premises.

Lot A248: The real estate taxes for 1983 were paid in error on this lot by Mr. & Mrs. Senn. The Senn's are owners of Lot A16. The Senn's will be reimbursed the \$39.90 they paid on A248.

Snow Plowing Contract: The Contracts are ready except for Foglio's for the Southern Section, a fuel clause has to be written. The Board will meet with Foglio in regards to this before completing the wording of this clause.

Tax Title Property: On June 11th, 8:00 PM, the Board will meet with the Planning Board and Conservation Commission members as stated under Section 4. of the Tax Title Property Ordinance so that they may deem what property should be held by the Town and not be placed up for public auction on August 10th. The Board also at this time will discuss the Town's Hazardous Waste Ordinance.

Planning Bd./Town Engineer: The Board of Selectmen agree that if the Planning Board voted to hire the Town's Engineer to check out the new subdivision on Ossipee Hill Road then the Planning Board should hire the Engineer to do the necessary work. A letter will be sent to the Planning Board Members.

Highway Entrance Permits: New Four (4) part Permits have been printed. The C.E.O. Foglio will collect a \$5.00 fee keep one of the copies and turn it into the Town Clerk, the other three copies will be given to the applicant, the applicant will go to the Road Commission and the Rd. Comm. will decide if the applicant is in need of a culvert, the Rd. Comm. will sign the Permit give the applicant one copy, keep one copy and turn a copy into the Town Clerk to be placed on file with the original copy the C.E.O. turned in to the Clerk.

Assessor: Mark Caldwell will be called and asked that he meet with the Board next Tuesday evening for a review of his work on the 1985 real estate valuations to date.

Special Town Meeting: At 7:30 PM. a meeting was held and the two Articles passed that the Town sign a twenty three year contract with RWS to dispose of the Town's solid waste and also a Solid Waste Disposal Ordinance.
