PRESENT: Andrew C. Woodsome, Jr. and Robert C. Fay.


MIKE EMMONS: Mike was is to inform the Board of what happened at the Mud Stompers event last week. The ambulance will not be going up there any more. He will not put his ambulance crew through that again. There was a lot of drinking with no police around at all, people gave the ambulance crew a hard time. The crew has stated to Mike that they refuse to go on a call up there any more without a sheriff or state trooper present. The Board asked Mike how possibly the burning at the dump could be handled. Mike suggested that possible burning just one day. The dump is closed Tues. and Thurs. Mike will discuss with some of the members of the fire dept. to see if they would be willing to burn on Thurs. when the dump is closed.

COUNCIL MEETING
May 17, 1988

Introductions were made.

SELECTMEN'S REPORT: Sel. Woodsome reported that the Town Attorney has written a Noise Ordinance for the Town, a Public Hearing on Hammon Enterprises petition to the Town for Sunday Sales will be held on May 24th at 8:00 p.m. this will be a referendum question on June 14th. A no parking ordinance has been enacted for both sides of Rte. 5 and Town House Road for a distance of 35 feet and on the East Shore Road in the Town's Right-of-way. The second dump hearing will be June 21st.

TOWN CLERK: Dianne announced that Bertha McAloon has been chosen for the part-time office worker. Several ballots clerks will be going to Augusta for a meeting and is getting ready for the June primary.

ROAD COMMISSIONER: No report.

SAD #57 DIRECTOR: Millard Genthner reported that the budget is a hot issue. He passed out the total voting outcome of the whole district. There is a special meeting on May 18th to discuss Article 14 and the Administration Article.

FIRE DEPT.: No report.

PLANNING BOARD: Larry Jacobsen represented the Planning Board. Two subdivisions have been approved. Straw Mill Measadows and Alder Acres. Have done on-sites inspections and have held several public hearings.

FINANCE COMM.: Steve Kasprzak reported all is quiet.

PARKS & REC. COMM.: Bob Gobeil reported that the fences are going up. Two fireplaces will be going up at the Rte. 5 swim area. Snowmobile club has added 4 more horseshow pits. The Lion's field has been done. May have to fence along side of Lion's due to cars riding on the field. Ossipee Pines is open, toilets are being worked one. Fence will be put up between Ossipee Pines and abutting property. Ossipee Pines will be open from dawn til dusk.

INDUSTRIAL DEVELOPMENT COMMISSION: No report.

ROAD REVIEW COMM.: No report.

ZONING BOARD OF APPEALS: Millard Genthner reported all is quiet.

CONSTALBES: No report.

CONSERVATION COMMISSION: Doris Dyer reported they are busy working on wetland mapping. A contract from Sewell will be presented to the Selectmen to sign. Steven Everett would like to be on the Conservation Comm.

HAZARDOUS WASTE COMMISSION: Ray Dyer reported that the new amended Hazardous Waste Ordinance will be mailed out. Household waste is a major problem.

REGIONAL WASTE: Frank Allen reported that there is a meeting coming up on Thurs.

TOWN PLANNER: Andrew stated that the Planning Board will be heading the comprehensive plan project. A member from the Planning Board will head the different committees. He is still reviewing subdivisions that are coming before the Board. There are currently 19 subdivisions before the Planning Board, majority is in the Lake Sherburne, New Road, West Road.
