

SELECTMEN'S MEETING MINUTES  
January 23, 1990

Regular meeting of the Waterboro Board of Selectmen.

PRESENT: Chairman Andrew C. Woodsome, Jr., Robert C. Fay, Dennis G. Abbott.

NEW BUSINESS:

KOLBE DRIVE: Several families were in to discuss several things with the Board. United Cable refuses to hook them up, refuses to even talk tot hem on the telephone, the lines are all laid. There are three out of the seven lots been sold. Sel. Abbott stated that the extension policy is to hook up cable within 500 feet. Will send a letter to United asking why they haven't hooked up cable and what their rationale is for not doing so. Will send a copy of the letter to the people living on Kolbe Drive. They were orginally told that the cable would be in by January. They have also heard that the road will not be approved at Town Meeting. The Road Review Committee recommends that the road not be accepted unti all of the houses are built due to constructions trucks doing damage to the road and the Town would be responsible. The Board explained the process of road acceptance. Bob Reinken has told them that he has insurance on the road. Sel. Abbott told them that the Town has no obligations to plow the road.

RICHMOND STEVENS: The Board sent a letter that Richmond was overpaid in 1989. Richmond stated that he was underpaid in 1988 and there is still a balance due from the Town. A check in May of 1988 was made to make up the difference that should have been paid in 1988. The Board will issued a check for Richmond next week for his regular monthly payment plus an additional \$1,808.83 for the 1987-1988 balance. Richmond also told the Board that his contract is up this year and needs to be renewed. Board will have an article drafted for the warrant for annual Town meeting to enter into negotiations.

DWAYNE MORIN: Dwayne reported the the soil borings has started at the Patent Leather site. DEP wants to take Ed Bradlwy's bill out of the reimbursement. Will pay for Jack Rand, Carol White and the price paid for the purchase of the lot. Jack Rand told DEP that Ed Bradley didn's work for then when they were doing the water search, so DEP doesn't want to pay for Ed's charges.

Board voted that the bylaws of the cable TV committee drafted by Ken Cole be accepted.

Sel. Fay stated that the letter that was sent to the snowplow contractors didn't do any good. Should either amend the contract or turn it over to Karen. Sel. Abbott stated that the contract will not be amended. Chm. Woodsome abstained.

Board voted to take the Finance Committee recommendation for Article 4 off the warrant for Annual Town Meeting.

Board signed the warrant for payment of bills and payroll.
