Regular meeting of the Waterboro Board of Selectmen.

NEW BUSINESS:

VICTUALER'S LICENSE HEARING: Chm. Fay opened up the hearing. Board voted and approved the following:

SHERIFF'S DEPT.: Don Martin, John Winslow, Dawn Tilton, Carole Cochran, Andrea Lefebvre represented Parks & Rec. Game Warden Mark Warren and Dep. Breen Savage and Constable Chauncey Gerry was also present. John Winslow presented the Board the hours proposed by Parks & Rec. The cost of a deputy will be \$11.17 per hour without a car and if a car is required it will be \$.30 per mile. Dep. Savage feels if a deputy is seen then there will not be a problem. The only problem is to have a deputy there early because if he gets there and there are already illegal parked cars then it will be an up hill battle to get the owners to move the cars. Also feels that the Town should have parking fines to generate money back to the Town. Could also have the deputy serve as Town constable and could also have the same officer for the summer. Chauncey Gerry feels the most crucial time is 2-5:30 p.m. Suggests having the deputy work 10-5:30 or 6 p.m. and 10-5 p.m. on holiday weekends and only spot check during the week. Chuck Binette feels the problem will be in the morning when the parking spaces are gone. Dep. Savage also stated that if the deputy has a car he can be used elsewhere in the Town. Mark Warren stated that the state has problems with restrictions if any are put on to control the use of the lake. If there is a parking problem okay, but if it is being used to control boats on the lake then the State has a problem with it. Chauncey asked if residents are not utilizing the picnic area can nonresidents be able to use it. Chm. Fay told Parks & Rec. members that they will have to go through Town Meeting to get approval of any changes in the parking spaces. Mark Warren stated that the wardens' service jurisdiction is on the water only, once they leave the water not under their jurisdiction. Chm. Fay would like the deputy 16 hours on weekends. Dep. Savage also told the Board that the Sheriff Department will address the speeding on Route 5 in front of the campground. Dwayne Morin suggested having one side for resident parking and the other side for nonresident parking. The Board will have Karen Lovell review the contract from another Town and the Sheriff Dept. and draft a contract between the Town and the Sheriff Dept.

DWAYNE MORIN: Dwayne discussed with the Board a letter that he has received from Charles Thornton. Dwayne has discussed this with Atty. Karen Lovell and she stated that the research will cost approximately \$2,000. if she does it. The Board voted that this information requested comes under the Town's Staff Research and Investigation Services Policy and that Karen Lovell should be responsible for getting the information requested. The Board also voted that a deposit should be made before any gathering of information is started.

The Board went into Executive Session at 8:45 p.m. to discuss personnel matters.

The Board came out of Executive Session at 9:00 p.m. and went back into regular session.
