

## SELECTMEN'S MEETING MINUTES

APRIL 20, 1993

Regular meeting of the Waterboro Board of Selectmen.

PRESENT: Chm. Dennis G. Abbott, John C. Monteith, Frank R. Allen Jr.

Also present: Finance Committee member Art Smith, and Selectmen's Assistant Dwayne Morin and Parks & Rec. Chm. Bob Gobeil.

### REPORT OF STANDING COMMITTEES:

DWAYNE MORIN: Dwayne presented to the Board the agreement between Shaker Valley Little League and the Waterboro Parks & Rec. Comm. for use of the Town's baseball and softball equipment for the upcoming season. Chm. Abbott and Parks & Rec. Chm. Bob Gobeil signed the agreement. Dwayne has contacted the Dewitt's on Pearl St. in regards to obtaining an easement for drainage across their property, they are in agreement and Dwayne will be meeting with them Thursday. The Board reviewed the letter received from Karen Lovell concerning rescue attendant involved in an accident on the way to a rescue call. Chm. Abbott stated that Atty. Lovell needs to clarify the contents of the letter clearly. Atty. Lovell has told Dwayne that she will write a corrected letter. The Board voted that Atty. Lovell write an additional corrected information letter and that the Fire Dept. be billed for her services. Dwayne reported to the Board that a fire hydrant on Rte 202 in front of the Shaffer residence was damaged this winter. Also a resident was seen throwing garbage out of his vehicle and there are witnesses that will testify seeing Billy Cortway throwing out the garbage. Board voted to contact the State Police. The agreement between the Town of Hollis and the Town of Waterboro allowing Hollis residents to use the Town of Waterboro's stump dump area has been approved by both Boards. Board of Selectmen from Hollis has signed the agreement. Bob Konczal has requested a map of all the parcels of land in the Town be made by Sebago Technics. Sebago Technics has submitted the cost for a 4 x 6 map and 11 x 17 map which will also show the roads in the Town to be approximately \$3,375. Bob has requested that it be paid out of the Assessor's account. The Board approved the purchase of the maps out of the Assessor's account. Dwayne also discussed with the Board the Julia Holt Trust Fund which has always gone into the cemetery fund. At the last Historical Society Meeting it was brought up that it was set up to purchase books. Chm. Abbott suggests giving the money to the Waterboro Public Library which is approximately \$15.00 a year. Voted, passed.

### NEW BUSINESS:

Chm. Abbott made the motion that all Selectmen's correspondence and mail to be put into a 3 ring notebook and collated and not be available to the public until the Board has reviewed it at their weekly meetings. Sel. Allen and Sel. Monteith approved.

The Board voted to mail out the Annual Town Report.
