

SELECTMEN'S MEETING MINUTES
July 27, 1999

Council Meeting held at 7:00

The Old Home Days Committee was welcomed and thanked for their tireless efforts.

Bob Gobeil outlined a brief history of the event.

Various committees reported on their activities.

The Selectmen's meeting was called to order at 8:15.

Discussed tractor fees. Willis feels that with the purchase of the new tractor and the increase in the monthly payment, that the fee should be increased from \$25.00 to \$30.00. Motion by Willis and seconded by Millard. Motion carried 3-0-0.

The subject of the Purchase Order policy was brought up by Brenda, making the motion that the policy be changed to stipulate that in the absence of the Purchasing Agent, purchase orders can only be processed with the signature of two Selectmen. Millard seconded the motion. Brenda made the motion to table the subject until the Assistant returns from vacation to provide her recommendation. Motion seconded by Millard. Tabled 3-0-0.

Millard brought up the subject of the Mast Camp Road. A citizen called him regarding excessive speed on that road. The suggestion was made that the Assistant write a letter to the State Police and the York County Sheriff's Department expressing concern. Also, that she research the process for posting that road - probably 15 miles per hour.

It was decided to have the Assistant cut a purchase order to have the burn pit at the dump cleaned and burned, and to include burning the leaves in that project.

The motion was made to have the Assistant draw up specifications to bid the site preparation and construction of a wall at the transfer station in accordance with the plans submitted. The invitation would be extended to the list of contractors outlined in the plan. The job will be bid as one project, including site preparation, forming and pouring the walls, and backfilling.

Further projects planned for the facility will be postponed until bides come in so the board will know how much is left of the appropriated \$50,000.
