3. Discussed the Comprehensive Plan Update. Need more town participation.
4. School Board to begin negotiations very soon. Held a meeting recently to remove some students from the school. They were removed permanently.
5. Discussed the need for a moderator for November 6th.
6. Reported a scare over the weekend regarding possible terrorism but was found to be a false alarm. Discussed procedures in light of what has happened.
7. Discussed the EMA meeting tomorrow evening. Pam warned to handle any suspicious mail with care, isolate it, wash hands immediately and call 911. Warned to be cautious but not overreact.
8. Discussed E911, target date is still Feb. 1st. Discussed the procedure for changing a road name after approved by the post office. Can be done by a vote of the Selectmen then would need to inform Pam so she can notify Augusta.
9. Reviewed upcoming meetings and included the Republican Town Committee meeting at 8 a.m. at Lee's Dairy Curl in support of Jim Libby for Governor.
