

SELECTMEN'S MEETING MINUTES

July 16, 2002

NEW BUSINESS

1. Motion by Eric and seconded by Willis to appoint Brenda Crenner, Motor Vehicle Agent, Frank Birkemose, Jr., Fire Chief, Scott Birkemose, Deputy Chief, Mark Sanders, Deputy Chief, Kirsten Pacyna, Deputy Town Clerk, Gerald Daigle, Assessor's Agent, Cheuncey Gerry, Constable, David Tebbetts, Constable and Kevin Nelson, ACO/Constable for fiscal year 2002/2003. Voted. Passed.
2. Motion by Eric and seconded by Willis that upon review of the Hollis Contract that it be signed and sent on to Hollis for their signatures. Voted. Passed.
3. Discussed a couple of complaints regarding two people fishing in the roped off swim area at Gobeil Park while children were swimming. Mike stated that if the board votes to put up a sign prohibiting fishing in the swim area that Parks & Recreation will have the signs made and installed. Motion by Willis and seconded by Eric that signs be made stating that "There will be no fishing in the area roped off for bathers at Gobeil Park." Voted. Passed.

OTHER

1. Discussed the current tipping fees and the potential increase as well as the proposed increase in assessment. Willis reported on how much tonnage has been taken into RWS in the past month. Also reported that \$7,689.75 was received in fees at the Transfer Station.
2. Doug reported that the town needs to hire an abstractor to research mortgage holders on a number of properties. Per the state you can add a \$13.00 charge to the lien which will cover the cost of hiring the abstractor. Motion by Eric and seconded by Willis to hire an abstractor to take care of current tax lien problems. Voted. Passed.
3. Doug noted that the vote on the Growth Control Ordinance will take place next Tuesday, July 23, 2002 at 7 p.m. in the town hall. Need as many as possible to come out and vote. Discussed different ways of assuring that only registered voters vote on this issue.
4. Motion by Willis and seconded by Doug to accept the minutes of 6/25/02 as written. Vote 2-0-1 with Eric abstaining as he was not present for that meeting.
5. Motion by Willis and seconded by Eric to accept the minutes of 7//02 as written. Vote 3-0-0.
6. Discussed the bill presented by Doug Blackwell at Council Meeting for the town to pay for his testing supplies for Lake Arrowhead.
7. Motion by Doug and seconded by Eric to pay the necessary bills and warrants. Voted. Passed.
8. Eric read the list of reminders for upcoming meetings.
9. Carole Cochran questioned the reports that there are multiple defects in the new building. Willis stated that there is a letter going out to the contractor and the chairman of the building committee listing things that need to be corrected. Also discussed things that need to be done at the Fire station.
10. Discussed a location for a new library.
11. Paul Verrell, Sr. requested a new charge from the new Board of Selectmen for the Waterways Committee.
