September 10, 2002

Called to order at 7:10 p.m.

Chairman Foglio opened the meeting with a moment of silence and pledge out of respect to the events of September 11, 2001.

York County Sheriff's Dept.: Report attached. Also reminded that school is open and the speed limit in school zones is 15 mph. There are very stiff fines for speeding in these school zones. Discussed diversifying his duties.

State Police: Reported that they are having a big problem with ATV's particularly in the Lake Arrowhead area. Reported that last month she wrote more summonses for ATV's than anything else.

Assessor: Reported that we have just shy of \$7 million in new valuation this year and that state revenue sharing will be approximately \$60,000 less. Estimate the new tax rate \$17.70-\$18.00. and should have a proposed tax rate in a couple of weeks. Discussed switching from NDS to Trio for Assessing. Noted that if they hadn't raised the valuation last year the tax rate could possibly be as high as \$20. this year. Would cost \$150,000 to \$200,000 to reevaluate the entire town and would take approximately 2 years to accomplish.
