

## SELECTMEN'S MEETING

June 9, 2009

Opened meeting at 8:00 p.m. by Selectman Abbott.

### NEW BUSINESS

1. Discussed making the Selectmen's workspace public and agreed that there will be two packets, one for the Selectmen with all the information and one for the public space removing anything confidential. Motion by Selectman Grover and seconded by Selectman Gale. Vote 4-0-0.
2. Discussed a workshop with the library on the roof and Selectman Gale questioned why they need another workshop. Selectman Grover suggested just putting it out to bid and all agreed.
3. Motion by Selectman Grover and seconded by Selectman Gale to appoint Karen Banks, Transfer Station/Recycling Committee, David Johnson, Transfer Station/Recycling Committee, Pete Jordan, Cemetery Committee and Chris Gionest, Cemetery Committee. Vote 4-0-0.
4. Moved the vote on the poverty abatement to next week.
5. Dustin stated that the Road Review Committee recommends voting to stop winter maintenance on Ossipee Hill Road Ext. for a period of 10 years. If someone moves onto that section it can be easily changed. Selectman Abbott requested that they layout some type of time frame of their plan to address these roads. Perhaps we just need to know about the next group of issues. Dustin suggested holding off for a couple weeks and compile the information then can meet in a workshop to review the information. Selectman Abbott stated that he can report during committee reports and then put on the agenda for the following week. Scheduled the public hearing for Ossipee Hill Road Ext. for June 30<sup>th</sup>.
